Rev. Charles E. Clinton, 70, took his last breath on Friday, July 17 at 8:16 p.m. He was born November 25, 1944 in Durham, NC to the late Elizabeth and Ernest Clinton. Charles was the oldest of 13 children. He was a graduate of Hillside High School in Durham, NC and received his undergraduate and Juris Doctor degrees from North Carolina Central University (NCCU). Charles was one of the founding members of Groove Phi Groove at NCCU. He was a member of Mt. Calvary United Church of Christ where he preached his trial sermon. Throughout his life Charles was a lawyer, entrepreneur, educator and minister. He touched many lives.

He was preceded in death by a sister, Priscilla Clinton, and two brothers, Anthony Clinton (Clara) and Ronald Clinton, Sr. (Mildred).
